UPDATING BYLAWS

Unit bylaws need to be updated whenever something changes in them or every 3 years if there are no changes. The most common changes to bylaws are changing the amount of dues, changing the meeting days, or changing the officers (adding or eliminating positions). The 3-year limit is from the date the bylaws were signed by the CAPTA Parliamentarian, which means that bylaws signed in 2011 or before are due for an update.

Here's how to update bylaws in a nutshell:

- Form a committee chaired by the parliamentarian to determine what, if any, changes are needed.
- The parliamentarian completes the E-Bylaws on the CAPTA site, prints out the new bylaws and sends them with required forms (see the Sixth District Website "Forms") to the Council Parliamentarian or to the Sixth District Parliamentarian if Out Of Council.
- Spanish/English Bylaws are available from the Sixth District Parliamentarian, not on E-Bylaws. After requesting a copy, complete the information and send in as explained above.
- The CAPTA Parliamentarian signs and returns the bylaws. The unit follows the steps to adopt the bylaws at a meeting.

There is help available for updating bylaws on the CAPTA website, the Sixth District Website, and most importantly from Council Parliamentarians and the Sixth District Parliamentarian. Trainings are scheduled periodically as well--sign up and come to one to learn more!

The 2014 state PTA advocacy goals are (1) adequate, stable, long term school funding, and (2) investing in pre-school.

Top performing education states spend \$16,000 - \$22,000 per student, and the national average is \$12,000 per student. LCFF and LCAP

The new school funding formula, the Local Control Funding Formula (LCFF) is two parts: (1) a per-student funding base (amount varies by grade level), plus (2) supplemental and concentration grants for low income, English Learners and foster youth.

Every school district is to have a Local Control Accountability Plan (LCAP) implementing the eight LCFF state priorities.

The LCAP roadmap: (1) school district drafts a plan, (2) the plan is presented to parent groups, there is written feedback and oral feedback at public hearings, (3) the school district responds to the feedback from parent advisory groups and individual parents, and (4) July 2014, there is a plan.

State PTA will provide the Conference power point presentation on LCFF and LCAP. Sixth District will post the presentation as soon as we receive it.

School Funding Update and Options

A repeated Conference concern was the need to educate voters about California's woefully inadequate school funding. PTA is very concerned about a misperception that Proposition 30 "fixed" CA public school funding.

Not only do California schools remain profoundly underfunded, but also, the Prop. 30 funds are temporary – expiring in 2016 and 2018. Rick Simpson, Deputy Chief of Staff for the Assembly Speaker, estimates California schools need an additional \$25 - \$35 billion, based on several sources including studies underlying the Getting Down to Facts report and the percentage of personal income California spent on education when CA was a top performing education state.

Rick Simpson said the additional funds won't come from the state, given the Proposition 13 two-thirds threshold requirement to raise revenues at the state level. So, options to address this severe education underfunding discussed at the Conference included:

Local Funding of Schools: CA constitutional amendment.

Rick Simpson urged local funding for our schools, via a CA constitutional amendment, authorizing school boards and/or their local communities to levy taxes for their school districts. Up until 1978 (before Prop. 13), local school districts funded their local schools through local taxes. The state could address any funding inequities between districts.

The local taxes should not, and would not, be limited to parcel taxes. Rick does not like parcel taxes, calling them regressive, not economically sensitive, and they do not grow as the economy grows.

Timing: The November 2016 ballot initiative. Why? 2014 will be a low voter turn-out (2016 will be a contested presidential election), and 2016 is closer to the Proposition 30 drop-off of school funding.

Oil Severance Tax

Senator Leno reminded conference attendees that "Oil is a natural resource. It belongs to all of us. Private entities are taking it for their own profit, returning nothing for our collective benefit." In 21 of 22 states – *all states where oil is extracted except California* – the states collect an oil severance tax.

Vehicle License Fee

CA had a vehicle license fee for 50 years. It's broad, not deep, grows with the population and it's progressive (those with more expensive cars, pay more). But it's politically poisonous, and not polling well even in as progressive a place like San Francisco.

Restore Commercial Property Taxes

Regularly re-assess commercial property to restore commercial property taxes that funded our schools when California schools ranked in the top five in the U.S. Commercial property held by huge conglomerates is still assessed at 1% of 1976 property value assessments.

Investing in Pre-school

A recent Stanford research study shows by age five, low income children are two years behind in language development.

A First-Five speaker stated that the wisest investment is in the early years. Early investment means less drop-outs, and less special education. Every \$1 spent saves \$7 later. As she noted,

"LCFF addresses the achievement gap. Early education investment *prevents* the achievement gap."

Asm. Weber added:

"The persistent achievement gap feeds our prison system, social justice system, poverty among women. People who go to preschool generally don't go to prison."

The greatest obstacle to early childhood education is funding. There is a consensus on quality early childhood education, but a lack of funding.

CA Budget Spending Proposals

According to Senator Leno, the state Democrats propose an equal spending distribution of state revenues: 1/3 to repay state debt, 1/3 to reserves, and 1/3 to re-invest in programs, while Governor Brown proposes 90% to debt repayment and reserves, and 10% re-investment in programs. So, we all need to watch as those negotiations go forward this Spring until the final budget is passed July 2014. The May 2014 budget revise will be a key document.

The need to set aside reserves is because California heavily relies on volatile revenue sources (personal income tax, sales tax). The reserve addresses shortages during economic downturns. If California relied more on stable property taxes (as do top performing education states), then a smaller reserve would be necessary.

Do's and Don'ts concerning PTA finances:

- When presenting a report at a meeting, the treasurer should be prepared to answer all questions promptly and to have records available.
- The executive board has a fiduciary responsibility to disclose to all members of the association all plans for expenditures and to secure the association's approval prior to incurring expenses. Members have the right and the fiduciary responsibility to ask questions and approve only expenditures that meet the PTA's Purposes and goals. The budget may be amended by the association provided notice has been given.
- Association funds should not be deposited in the personal account of the treasurer, nor should they be deposited in any school/school district account.
- Two PTA members, one who is a board member or chairman, must always count the money (in every situation such as fundraising and membership envelopes) and both should sign a Cash Verification Form verifying the amount. Each should receive a copy of the form. If the treasurer should sign the Cash Verification Form of the person delivering the funds indicating receipt of the funds after counting the funds again.
- All monies collected should be given to the treasurer without delay and deposited into the PTA bank account.
- The treasurer pays by check – never by cash – all bills as authorized. Purchases should not be made without prior authorization.
- Submit all check requests (authorizations for payment), receipts, bank statements, cancelled checks, association approved budget, financial reports and both executive board minutes and association meeting minutes to the auditor for the semiannual audit.
- The Audit Report must be supported by the Audit Checklist and recommendations. All three documents comprise the "audit report" that needs to be forwarded through channels.
- Every association must file the appropriate Form 990 with the Internal Revenue Service. Every association must file the appropriate Form 199 with the California Franchise Tax Board.
 - When tax filings are late, incomplete, or not filed at all, the PTA will eventually receive notices requesting further information, a prompt filing, or even penalties and interest from the IRS. Not acting quickly can become very expensive. **Contact the District PTA treasurer for assistance as soon as a notice is received.** Always respond to a tax notice immediately! Do not throw the notice away or ignore it.

Records retention schedule

It is very important the certain PTA records be retained. Listed are items that must be reviewed on a periodic basis and kept in a safe place. Develop a record retention policy based on this list.

PERMANENT STORAGE

- Audit reports
- Articles of Incorporation
- Canceled checks, for important transactions (e.g., taxes, contracts)
- Checks should be filed with papers pertaining to the transaction
- Corporation reports filed with the Secretary of State
- Legal correspondence
- Insurance records:
 - Accident reports/Incident report
 - Claims
 - Policies
- Ledgers
- Minutes of executive board, association and committees (bound)
- PTA Charter
- Tax documents:
 - Exempt status
 - Group exemption
 - Letter assigning Employer Identification Number (EIN)
 - State and federal tax forms, as filed
- Correspondence with state or federal agencies
- Trademark registrations



Consider getting a file cabinet at your school site so that PTA officers don't misplace these items at home or move away with them.

Treasurer's checklist for the Spring

Current Treasurers

- Ensure all per capita dues have been forwarded through channels.
- Issue convention advances or reimbursement checks for authorized expenditures for elected delegates.
- Request authorization and pay all remaining outstanding bills.
- Compare year to date income and expense to budget, avoid last minute surprises
- Prepare Annual Financial Report.
- Prepare books and financial records for end-of-term audit and provide to current auditor, as stipulated in the bylaws (after close of fiscal year).
- Provide training to your successor.
- Give financial records and materials to the incoming financial officer (except those in audit).
- Assist the incoming officers in changing bank signatures.
- Prepare tax return (990N) or coordinate preparation of tax return (990EZ or 990).

Newly Elected or Continuing Treasurers

- Treasurer-elect chairs budget committee.
- Board-elect develops and adopts preliminary budget based on proposed PTA programs for the upcoming year.
- Present proposed budget to the current executive board and the membership for adoption at the last PTA association meeting of the year. (This allows the board-elect the ability to cover routine summer expenses as outlined in the bylaws.)
